Written procedure number 5, MC Decision 9/2024 (08.02):

- Deadline for LSP full application moved to **11 March 2024, 15h**
- 7th partner in duly justified case - an extra possibility

More time to adequately answer the conditions, consult with JS and write full application form and submit via INTERREG+ system

- All 4 application representatives met with the JS, 7 meetings were held
 - constructive, informative
 - applicants understood and accepted the conditions
 - considerable progress was made
 - communication goes on in other forms
 - JS open for more consultation meetings if needed

Call for proposals:

- Non-competitive targeted call based on invitation, partners known
- Entire allocation of Objective 3.2 (ISO 2): 2 863 636 EUR IPA funding
- IP: The goal of mitigation of freight traffic by developing the border-crossing point Hercegszántó-Bački Breg
- To be launched as soon as the technical requirements are met
- Deadline is not set - but should be in 2024
- Assessment starts as soon as the application is submitted
- The aspect of climate resilience will be handled by contracting
- Partners not receiving financial support should be listed in the SC

Application package – simplified

- Guidelines for applicants – contains most of the data
- Indicator guide – included in GfA
- Eligibility guides – same as 1st CfP
- Visibility manual – same as 1st CfP

However – highest level of communication activities for OSI partners

- Assessment and selection of criteria in GfA

MC Decision 10/2024 (27.02): The application package for Operation of strategic importance is approved and the call for proposals may be launched as soon as the technical requirements are met
